During the Pandemic our main program, A Walk in the Park, was discontinued in March as we could not get a permit to serve in the city park. We were able to get food at the Midwest Food Bank and some food donations from organizations not being able to serve clients. We first took this excess (including PPE) to outreach workers and organizations dealing directly with people. Then we provided some food bank food for challenged neighborhoods. We distributed over 9973 tons of food. Clothing, \$26.97; Food, \$1961.64; Gasoline, \$714.32; Hygiene, \$116.27; Fees & Permits, \$763.50; Literature, \$85.16, Insurance, \$866.22
